We should know for certain whether the event will move forward around August 15. I suggest continuing to make your hotel reservations because they can always be cancelled in the event that we cannot meet.

On a state department level, I know many of our units are just now starting to meet again. Please remember that all units are required to have an election even if the officers are staying the same. If you do elections every April, you can continue to do so. 2020-2021 will just be a unique year and officers will serve shorter terms.

Since we are delayed in our annual unit elections, that also means the roster for 2020-2021 will be delayed. That is also why it is so important to get those reports in once the unit has held elections.

All units Adjutants should have received the annual mandate letter. This is due no later than September 30, 2020. Please remember that VA Hospital and Veteran Home Representatives cannot receive disbursement of the hospital mandate until all payments have been made. Don't hold up this important distribution – get yours in today.

We are also now in the time that the annual financial report is due. I know we are facing unknown waters right now, but please work together and get this done so that all of our units meet the deadline of September 30, 2020. Units who do not submit the annual financial report are considered indebted and have no voice or vote. Don't do that to your members. Please reach out to me if you need help. I am a phone call, text, or email away. Also, don't forget to get your 990-N e-Postcards done. These are due no later than November 15, 2020. If you cannot do it, just let me know and I can for the unit. It is so expensive and difficult to get the tax-exempt status back once it has been revoked, so don't delay in getting this done.

Year-end financial figures for the state department will be mailed in the coming months. I want all units to take a good look at the VAVS donations. I know that the end of 2019-2020 was very odd, but we need to make sure that we are being good stewards of funds. Donations should be made to the VAVS Program and other DAV/A Programs. We cannot continue to make donations to community programs. We realize that they do great work, but if our donors wanted those funds to go

there, they would have donated to them. I'd love to see us get back to the "good old days" with hospital donations. The representatives count on the donations for programs. If you have been donating, make sure that you are sending them through the state department.

I am a member of Schumann-Heink Unit #30, Stevens Point. I have been a member of the Auxiliary since 1990. I have served as adjutant/treasurer of my Unit for 10 years. I have never served in any other office in my Unit.
